CERTIFICATE OF OCCUPANCY will be issued once all required approvals have been obtained.

If a **TEMPORARY CERTIFICATE OF OCCUPANCY** is authorized , the Temporary Occupancy Fee per the current [Master Fee Schedule | Ridgefield, WA](#) is required prior to the Certificate being issued. ***THE NUMBER OF DAYS FOR TEMPORARY OCCUPANCY IS DETERMINED BY THE BUILDING OFFICIAL.***
