- 1. APPLICATION:** Provide one (1) copy of the completed Application form with original signature(s).
- 2. CHECKLIST:** Provide one (1) completed copy of this submittal checklist.
- 3. LEGAL DESCRIPTIONS:** Provide copies of recorded deeds in a chain of title sufficient to determine a legal lot. A complete deed history is recommended.
- 4. SURVEYS AND PLATS:** Provide copies of recorded surveys or plats of subdivisions, short subdivisions, or other legal divisions of property to determine the legality of the lot(s).
- 5. SITE PLAN:** If there are any structures on the lot, provide a site plan prepared by a surveyor licensed in the State of Washington, showing building locations and dimensions.
- 6. WRITTEN STATEMENT:** Submit one (1) copy of a written statement as to the situation necessitating a legal lot determination, and any other information that would be relevant and helpful in a legal lot determination.

C. APPLICATION FEES:

Fees must be paid at the time of application via the online portal.

- Lot Determination (two lots)** \$450
- Lots over two - additional \$50 per lot** \$50
