

Equip Abrams Park Well 11 Project

The City of Ridgefield is seeking bids from highly qualified contractors to provide all labor, supplies, equipment, materials for the Equip Abrams Park Well 11 Project. This project includes equipping Well 11, and other work, all in accordance with the attached Contract Plans, these Contract Provisions, and the Standard Specifications.

The Work shall be fully complete within 75 Working Days from the Notice to Proceed.

The City of Ridgefield places great importance on the integrity and accuracy of the official plan holders list. Users may then download bid documents from the J2 plan center. Users will be notified by email containing a link which will provide all project updates and addenda. No other plan centers are authorized to disseminate bid packages. The fees for obtaining a bid package are non-refundable.
