

**City of Ridgefield
Invitation to Bid for**

P20013: N 10th Ave Rehabilitation

The City of Ridgefield is seeking bids from highly qualified contractors to provide all labor, supplies, equipment, materials for the improvement of reconstruction of approximately 2400 linear feet of N 10th Street between Royle Road and the eastern terminus of the roadway using full depth reclamation (FDR). Work shall include pulverizing the existing asphalt and Blending in aggregate for a 6-inch base layer. Project shall be finished with 3 inches hot mix asphalt (HMA), shoulder rock, and asphalt driveway aprons and other work, all in accordance with the attached Contract Plans, these Contract Provisions, and the Standard Specifications.

The Work shall be fully complete within fourteen (14) Working Days from the Notice to Proceed.

Bid packages may be picked up at J2 Blue Print Supply Co, located at 8100 NE St. Johns Road, Suite B101, Vancouver, Washington. The City of Ridgefield places great importance on the integrity and accuracy of the official plan holders list. Therefore each bidder will be required to register at the following email address: Bid@j2b.com. Once registered, bidders will receive a username login, password and download rights. Users may then download bid documents from the J2 plan center. Users will be notified by email containing a link which will provide all project updates and addenda. No other plan centers are authorized to disseminate bid packages. The fees for obtaining a bid package are non-refundable. Registration as a plan holder is included with the purchase of a bid package, and is required to obtain Contract Addenda.

All project specific questions, requests for substitutions, or requests for clarification must be sent to Julia Denton, Procurement Specialist, via email to Bids@ci.ridgefield.wa.us and be received by 4:00 p.m. on **Thursday, August 13, 2020**. Incomplete or late inquiries may not be considered.

Sealed bids must be received by the City no later than 11:00 AM (Pacific Time) **Tuesday, August 25, 2020**. Submissions received after the specified time will not be accepted. The City of Ridgefield is not responsible for delays in delivery. Official delivery time shall be documented by City affixed time/date stamp.
